### **Committee Structure**

The committee enquired about the about selection process (i.e. gender balance, age). Boral to provide a response.

### **General Running of Meetings**

A request to circulate agenda in advance of meeting was made. Facilitator agreed to action this in discussion with Boral.

A request was made to provide an on-line meeting format if committee members were away. (There is facility at the venue for this) Facilitator to discuss with Boral.

The question of more observers/members being invited to sit in on the meeting to be considered. Facilitator to discuss with Boral.

Document sharing capability to be looked into to facilitate information exchange.

Meeting minutes to be placed on Boral website so DEM can refer to them from their website.

Community requested that future meetings involve the regulators addressing PM10 levels, and other data enquiries.

### **Other points**

There was a general enquiry as what the TEOMs could measure. The answer was that PM 2.5, PM 10 was measured but the PM100 not.

The committee asked if EPA/DEM could provide information on the basis of how TARPS are structured.
