KEY TERMS

Information on how to enter and prizes form part of these conditions. By participating entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.

Details	
Promoter	The Promoter is Boral Limited (ABN 13 008 421 761) of Level 3, Triniti 2, 39 Delhi Road, North Ryde NSW 2113
Eligible Entrants	<p>Entry is open to residents of Australia 18 years of age and over.</p> <p>Employees, contractors and their immediate families of the Promoter, its related entities and any agencies associated with this competition are ineligible to enter.</p> <p>To be eligible for the Boral Reseller prize you must be an Active Boral Reseller.</p> <p>To be eligible for the End-User/Customer prize you must be a valid End-User / Customer.</p>
What is a valid End-User/ Customer?	<p>A valid End-User/Customer is one who purchases a packaged Boral cement product from a registered Boral reseller.</p> <p>Purchases made directly from Boral will not qualify a person as an End-User/Customer for the purposes of this competition.</p>
Who is an Active Boral Reseller?	<p>To be an Active Boral Reseller a person must be a registered Boral reseller with an active Boral account.</p> <p>An account is “active” if Boral has received a product order in the 30-day period prior to the draw date.</p>

<p>How to Enter</p>	<p>To enter, each entrant must, during the Entry Period, purchase a packaged Boral cement product from a registered Boral Reseller and upload a picture of the relevant docket, invoice or receipt as proof of purchase to the online entry form found at www.boral.com.au/green-and-gold, along with the number of packaged Boral cement products purchased, complete their name and contact details and provide the name and State of the registered Boral Reseller from whom they have purchased the product.</p>
<p>Limits on Entry</p>	<p>Multiple entries will be accepted. Each entry must be unique, submitted separately and supported by a proof of purchase docket, invoice or receipt.</p> <p>Entries which, in the opinion of the Promoter:</p> <ol style="list-style-type: none"> 1. <p>Cancellation, suspension or modification</p>	<p>If for any reason any aspect of this Promotion is not capable of running as planned, including (without limitation) by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a Prize, subject to State or Territory regulation.</p>

FURTHER DETAILS

- 1) Where entrants are required to upload a photograph to enter, entrants must adhere to the following conditions:
 - (a) by submitting a photograph, entrants agree to the photograph being made available for public viewing;
 - (b) all photographs are subject to the approval of the Promoter. The Promoter reserves the right to vet all entries at any time and (if applicable) reserves the right to request the removal of any entries from any Platform or such websites at any time in its absolute discretion. However, the Promoter is not responsible for any photographs uploaded to any Platform (as applicable) or website and visitors to the site view it at their own risk;
