

Boral Linwood Quarry Community Update

December 2018

In the lead up to the end of the year, we would like to give you one last update on operations and plans at the Boral Linwood Quarry, including progress on the new haul road and our new mining proposal.

Proposal to move quarry 'East' submitted to government

In our last few newsletters, we've mentioned plans to extend the Boral Linwood Quarry towards the East. Boral can confirm that this proposal was lodged with the Department for Energy and Mining (DEM) early in December.

Currently, Boral holds a Mineral Claim (MC) over a parcel of land located to the south-east of the quarry site. Over the last few years, Boral has been exploring the possibility of developing the quarry in this direction.

In order to progress this proposal, Boral has been working on a Mining Lease Proposal (MLP) for consideration by DEM. The lodgement of this document will now trigger the start of an extensive assessment process that will involve consultation with relevant government agencies as well as a statutory consultation process.

Boral is committed to supporting DEM in its communications to neighbours during this statutory consultation process.



Have your say

For new lease applications, like the Boral eastern extension, the *Mining Act 1971* requires the Minister

for Mineral Resources to publish a notice in a newspaper inviting the public to make written submissions concerning the proposal.

The application is always advertised in The Advertiser and the Government Gazette. Local newspapers are also used in some cases. This will be decided at the discretion of DEM.

The usual time period for consultation is a minimum of four weeks, but this may be increased at the discretion of DEM for projects which are:

- of significant public interest, or
- of large scale and high complexity, or
- where the consultation coincides with public holiday periods.

Boral understands that with the recent submission of the Linwood MLP, DEM will likely run this consultation period in the first half of 2019, potentially in February/March. More information regarding the process can be found at: www.energymining.sa.gov.au

Design of new road approved

The designs of the new access road from the Boral Linwood Quarry to the Majors Road-Ocean Boulevard intersection have now been approved by the Department of Planning, Transport and Infrastructure.

With the designs finalised, Boral and developers Gasparin Group, are working through the process with the aim of appointing a contractor to undertake the works.

A formal tendering process is underway, and five potential contractors have been engaged to provide pricing for the work.

Boral has split the haul road works into two sections; that of the main haul road and the intersection. While these will be tendered separately, it does not exclude the same company being appointed for both.

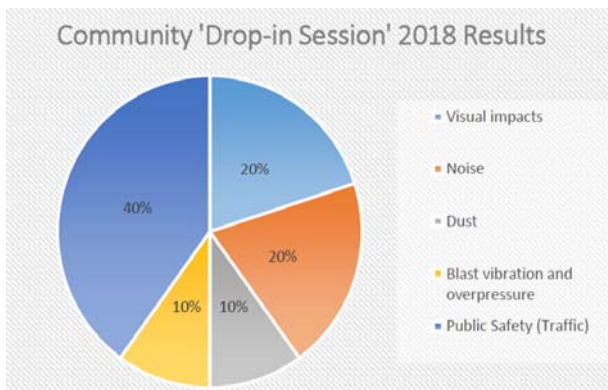
The aim is to engage a contractor sometime in the new year with the works commencing in the first half of 2019.

Feedback from drop-in sessions

Thank you to everyone who attended our information 'drop in' sessions earlier in July this year. You gave us valuable feedback that we have incorporated into the development of our operations.

In all, we hosted 32 individuals to our sessions, and these included stakeholders from the Hallett Cove, Marino and City of Marion communities, as well as government representatives from the DEM and the Environment Protection Authority.

A total of 12 feedback forms were completed and submitted, and the below graph shows the spread of topics covered.



Feedback received has been used to inform control and management strategies and the development of proposed outcomes and criteria for the regulation of the site. Specific detail will be contained in the MLP and Boral encourages all stakeholders to review the documentation through the statutory consultation period that will be overseen by DEM.

End of year closedown

As we approach the end of the year, the Boral Linwood Quarry will close from 21 December, 2018.

A partial re-opening will occur on 2 January, 2019 where sales will become available. Full production will recommence on 9 January, 2019.

During the shutdown, there will be some maintenance undertaken on site. Additionally, the site sprinkler systems will be serviced prior to shutdown and the automated timers will be amended to increase frequency of water spraying.
