2.3 Other hazards

This product is the result of high temperature calcination of the component substances. Due to its unique crystalline structure the properties of this finished material do not necessarily reflect the properties of the component metals or oxides. Repeated overexposure to this compound may cause eye, skin and respiratory tract irritation. Some compounds of the metals used in the manufacturing of this material have demonstrated various toxic properties. However, there is no evidence that this material has these toxic characteristics.

4. FIRST AID MEASURES**4.1 Description of first aid measures**

Eye If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

Inhalation If inhaled, remove from contaminated area. Apply artificial respiration if not breathing.

Skin If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by a Poisons Information Centre or a doctor.

Ingestion For advice, contact a Poisons Information Centre on 13 11 26 (Australia Wide) or a doctor (at once). If swallowed, do not induce vomiting.

Non flammable. May evolve toxic gases (chromium oxides) when heated to decomposition. Dust may form explosive mixtures with air.

Treat as per requirements for surrounding fires. Evacuate area and contact emergency services. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.

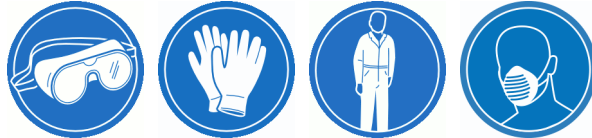

Acute toxicity This product is expected to be of low toxicity. Based on available data, the classification criteria are not met.

Skin Not classified as a skin irritant. Contact may result in mechanical irritation, redness and rash.

Eye Not classified as an eye irritant. However, this product may cause mechanical eye irritation with redness and lacrimation.

Sensitisation Not classified as causing skin or respiratory sensitisation.

Mutagenicity Insufficient data available to classify as a mutagen.

Carcinogenicity Not classified as a carcinogen. There is inadequate evidence in experimental animals for the carcinogenicity of chromium (III) compounds (IARC Monograph, Volume 49).
